SITA Trust

Delegates at the York, UK Biodiversity Partnership Conference 2009, were some of the first to access the content of a new publication, which highlights the results of successful partnership working between Natural Economy Northwest and SITA Trust.

Five SITA Trust Enriching Nature projects were enhanced through NWDA funding, to demonstrate the value that biodiversity projects also bring to the economy and the community. The new publication, which focuses on these case studies, ideally suited the Conference theme of The Value of Biodiversity.



The case studies were publicised and distributed at a SITA Trust event at the House of Commons in February. Marek Gordon, SITA Trust Chairman and CEO said: "This is a new language and a new approach and has shown that the SITA Trust biodiversity projects are also delivering local economic and community benefits."

Growing Natural Tourism: Guidance for Project Managers

Natural Economy Northwest has recently published three new project guidance reports

- Putting The Green In The Grey - Creating Sustainable Grey Infrastructure
- How To Deliver, Measure and Demonstrate the Economic Contribution of the Natural Environment at a Project Level
- Growing Natural Tourism: Guidance for Project Managers

The first is targeted at developers, planners and project managers with responsibility for developing physical (grey) infrastructure. It offers a framework for the identification of the

additional environmental benefits derivable from projects intended primarily to deliver economic outputs.

The second focuses on those already working in the natural environment. It helps these practitioners understand, maximise and communicate the economic, social and environmental benefits attainable from their projects. The aim of this report is to enable the user to demonstrate the win-win situation that results, to help support the case for investment in the natural environment.

The third draws upon natural tourism development work, as well as five demonstration projects, to provide guidance and articulate the socio-economic and environmental benefits from such projects, with sustainability an integral issue.

NENW Programme Director, Dr Will Williams, says: "These guidance reports contain insights that should be integral to project planning, fostering, as they do, a deeper understanding of the economic and social benefits of natural environment projects and the best way in which to communicate and deliver these.

"With case studies and signposting that highlights where to seek advice, supporting evidence and funding, these are excellent guides for project leaders wishing to harness the benefits of natural environment projects."



Summing Up the Benefits

New research summaries have been added to the NENW website, drawing upon the Growing Natural Tourism report, the three recent guidance reports and various SITA Trust case studies.

Towards the NENW Legacy for the Region

Natural Economy Northwest has moved its legacy work forward through a NENW Board-endorsed proposal which calls for the formal establishment of a Northwest Green Infrastructure Service, to build on the work carried out by NENW.

The proposal was discussed by the key regional agencies of NWDA, 4NW, GONW, Natural

England, EA, FC, HCA, NHS and CABE in January. We are pleased to report that £90k of the desirable £200k pa has now been pledged which means that the Regional Green Infrastructure Service can now develop, based on the GI Unit at The Mersey Forest. Other elements of the legacy are proceeding separately, such as the integration of natural environment advice within Enworks, inclusion of key NENW products on the Business Link website and the promotion of natural tourism through RDPE and HLS. The remaining challenge seems to be integrating the learning from NENW in training and development programmes in the Region.



Green Infrastructure Prospectus

This prospectus has been drafted by the partners in the Green Infrastructure Steering Group led by Paul Nolan, Director Mersey Forest. It sets out for the RS2010 process, the benefits of integrating the Green Infrastructure approach and advocates the need to plan, invest and manage the environment like any other critical infrastructure, as an integral component of not only economic recovery but also future sustainability.



Valuing Economic Benefits

The Genecon contract facilitated by NENW and funded by 5 RDAs, Northern Way, Natural England, Tees Valley and Defra continues to make good progress on developing the toolbox for quantifying and valuing the economic benefits of GI in project development and appraisal. Although NENW has been a catalyst for this contract, the project goes beyond the NENW programme; it is funded and managed separately and it part of the NENW legacy. The draft toolbox has now been issued for consultation.



Natural Tourism

Natural Tourism - its promotion through RDPE and the Higher Level Stewardship scheme of Natural England

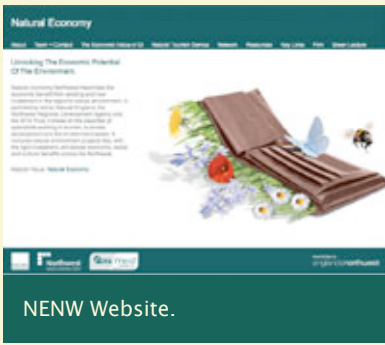
This contract with Rural Innovation, funded by Natural England and Forestry Commission, is to explore the potential for developing natural tourism focussing on 2 pilot projects - St.Helens and the St Bees Colourful Coast. The report will include guidance for further development. Again this contract represents part of the NENW legacy.



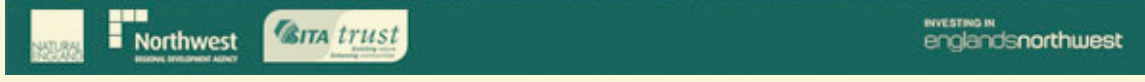
Bowing Out In Style
